MINUTES OF ANNUAL GENERAL MEETING 2024

1. Address by Chairman 主席致词

The recent activity on TikTok Sellers Workshop, we understand that consumers are changing their habits to buy shoes on other platforms such as Shopee, Lazada or TikTok. On the same day, a bag manufacturer from Johor Bahru attended, their production increased from online or live broadcast merchants, including TikTok sellers. From my point of view, the market requires shoe factories to manufacture and produce shoes, while retailers or wholesalers must move towards online or live-streaming sales trends. The TikTok team shared that the top 10 shoe sales came from unknown brands rather than brands we find in the physical stores, and the sales volume several times higher.

最近在 TikTok 卖家研讨会上的活动，我们了解消费者改变买鞋的习惯，转型在其他平台买鞋，如 Shopee, Lazada 或 TikTok。当天有位来自新山的包包厂家 出席，据了解目前产量增加，都是来自网上或直播商家，包挂 TikTok 卖家。以个人分析市场需要鞋厂制造及生产鞋子，而零售商或批发商必须迈向网上或直播平台销售趋势。TikTok 平台分享 10 大鞋销售量来自进口品牌而非著名品牌，而且销售量翻几倍。

We have CPTPP, RCEP and other FTAs, these agreements provide Malaysian businesses with advantages like lower or zero customs taxes, making them more competitive and contributing to Malaysia's economic sustainability. Malaysia imported finished product – complete shoe with ZERO custom tax but export to these countries we are required to pay other taxes eg Luxury-goods Sales Tax in Indonesia, Turkey imposed US\$1 for each pair of imported shoes, China imposed 8% custom duty imported goods with Form E and 100% without Form E, these are unfair trade. We will negotiate with government agency on this matter and seek for better solution.

我们有 CPTPP、RCEP 和其他自由贸易协议，这些协议为马来西亚企业提供了降低或零关税等优势，使他们更具竞争力，并为马来西亚的经济可持续性做出贡献。马来西亚进口成品 - 完整的鞋子，关税为零，但出口到这些国家，我们需要支付其他昂贵税款，例如印度尼西亚的奢侈品销售税，土耳其对每双进口鞋征收 1 美元，中国征收 8% 的关税进口商品，表格 E 和 100% 没有表格 E，这些都是不公平贸易。我们将与有关政府部门讨论，并寻求更好的解决方案。

When applying for a bank loan, ESG is important as corporate evaluation criteria based on corporate environmental, social, and corporate governance performance rather than traditional financial performance and the loan amount approval based on ESG index. Briefing by MIDA on 17th May of The Domestic Investment Accelerator Fund (DIAF) – ESG Adoption is a matching grant for ESG adoption that was introduced to support Malaysian-owned Small and Medium Enterprises (SMEs) and Mid-Tier Companies (MTCs) in the manufacturing and selected services sectors for the transition into ESG practices.

The Government will implement the Electronic Invoicing System (e-Invois) in phases to cater for the development of the digital economy and the digital transformation measures of the Inland Revenue Department. The e-invoicing system will be implemented in phases, with the first phase of mandatory implementation of the e-invoicing system from August 1 for taxpayers with an annual revenue or annual turnover of RM100 million and above. Currently, the system is still in the experimental stage, we will seek for suitable training if members need.

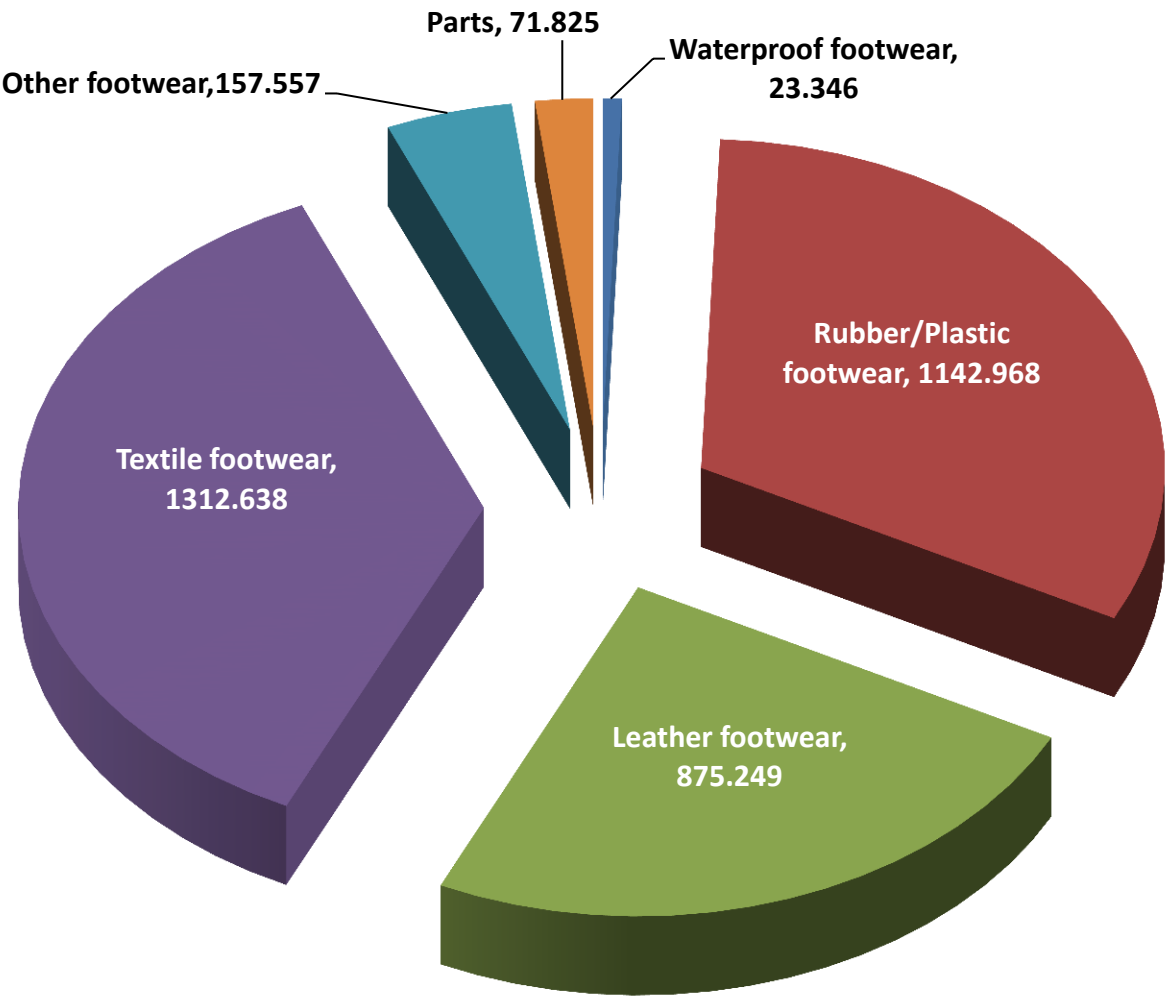
