MINUTES OF ANNUAL GENERAL MEETING 2025

1. Address by Chairman 主席致词

Chairlady Ms. Rachel Foo expressed her sincere appreciation to all members who took the time to attend the meeting.

主席胡晓薇向所有拨冗出席会议的会员表达诚挚的感谢。

The Association has conveyed its feedback to YB Yeoh that the extension of SST and the implementation of e-invoicing do not contribute to economic growth but instead place additional burdens on SMEs. Many SMEs are struggling to adapt to the increased administrative workload, which may ultimately force some to cease operations. Furthermore, local SMEs face intense competition from cross-border e-commerce sellers operating globally.

本会已向杨巧双部长反映，销售与服务税的重大调整与扩大以及电子发票的实施，不但未能促进经济发展，反而加重了中小企业的负担。许多中小企业难以适应新增的行政与合规工作量，甚至可能因此被迫关闭。此外，本地中小企业还需面对来自全球的跨境电子商务卖家所带来的激烈竞争。

It was proposed that foreign sellers operating on e-commerce platforms such as Shopee, Lazada, TikTok, and Temu should be required to establish companies in Malaysia and pay taxes as Malaysian entities. Currently, the industry is facing unfair e-commerce practices, where imported products enter Malaysia without tariffs, while Malaysian exports are subject to 100% customs duties. The Association recommends negotiating reciprocal trade agreements to ensure fairer market access for Malaysian exports under FTAs.

本会建议，凡在 Shopee、Lazada、TikTok、Temu 等电子商务平台上经营的外国卖家，应被要求在马来西亚设立公司，并以马来西亚企业身份依法纳税。目前行业正面临电子商务不公平竞争的问题，即进口产品免征关税进入本地市场，而马来西亚出口产品却需缴付高达 100% 的关税。因此，本会呼吁政府就对等贸易协议展开谈判，以确保马来西亚在自由贸易协定下的出口产品能获得更公平的市场准入。

Moving forward, the Association will organize more Members' Day events to connect TikTok shoe sellers with local manufacturers, as many online sellers are unfamiliar with how to engage local manufacturers. It is hoped that members will actively participate in these initiatives.



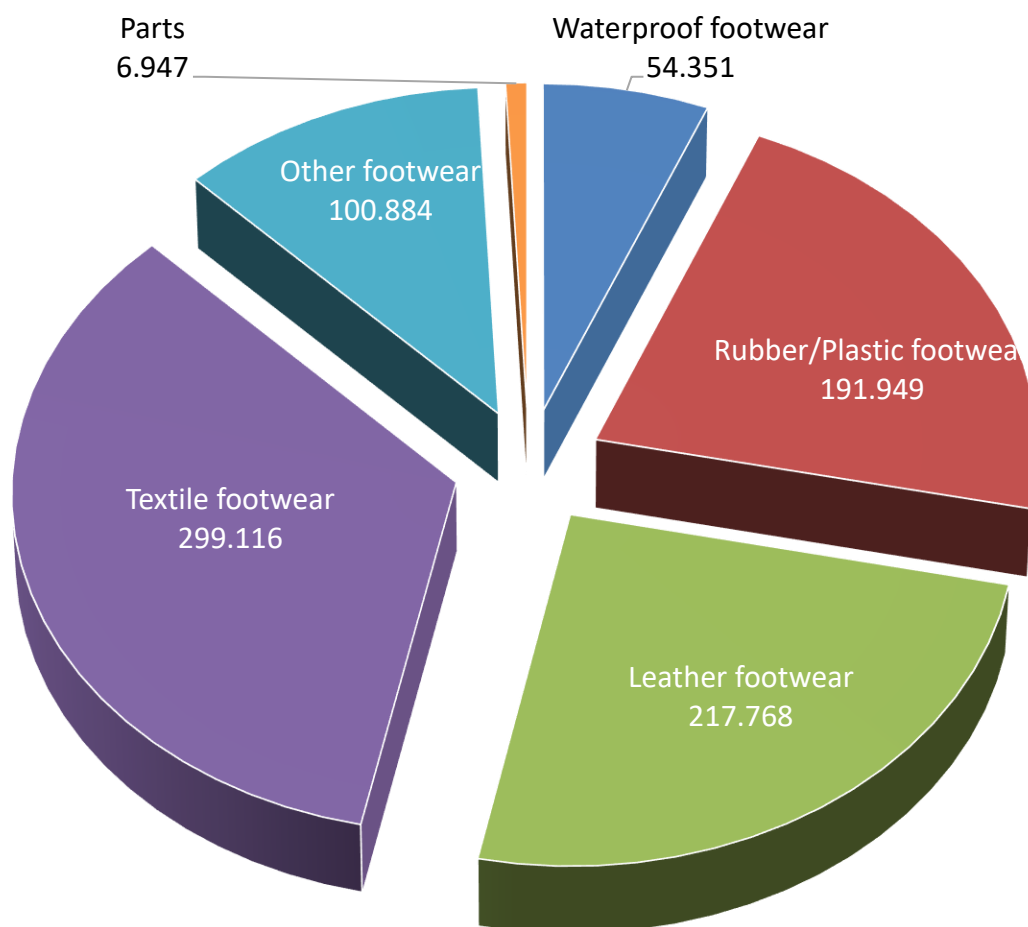

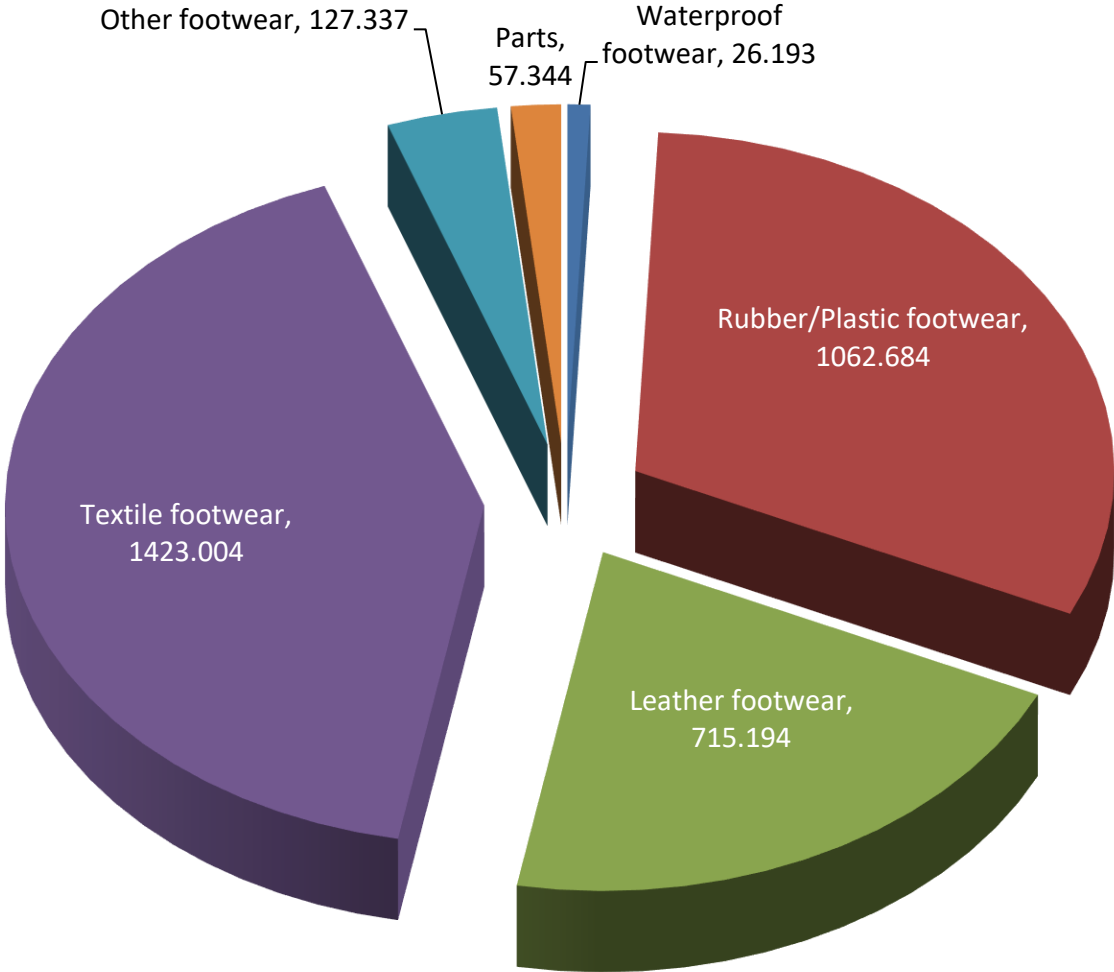
